Introduction

This document compares the content of the GCSE (9-1) Psychology for first assessment in 2019 (J203) with the content of the legacy specification. We hope that this can assist with your planning of schemes of work, and allow you to easily recognise the areas of your current schemes of work that can be carried forward.

The new specification consists of two components, each containing three topics, with research methods included in both. For each topic learners will be required to study two core studies *. Also, the new specification has a focus on mental health, and has been developed with <u>Time to Change</u>, England's biggest programme to challenge mental health stigma and discrimination, run by the charities Mind and Rethink Mental Illness.

Changes to assessment

- Two assessments both worth 50% of the GCSE qualification
- A minimum of 20% of the overall marks in both components are for the assessment of Research Methods
- A minimum of 10% of overall marks across the two components are for the assessment of mathematics relevant to research methods in psychology
- A 13-mark question will appear in section C of both papers and will require learners to make a judgement on a specific area of psychology, or as a synoptic item.

Assessment Objectives

The new Assessment Objectives are not a dramatic change from the legacy ones. There are still only three, one accrediting knowledge, one accrediting application and one accrediting analytical and evaluative skills.
