THE QUALIFICATION

Our Entry Level Certificate in History is designed to engage and encourage your students through an exciting curriculum. There's a wide choice of inspiring topics ranging from Crime and Punishment to modern American history and the Vikings.

It can be co-taught with GCSE (9–1) History qualifications.

Entry Level History has three parts:

- A thematic unit that looks at a broad sweep of history on a theme such as Crime and Punishment, Health or Migrants
- A depth study that focuses on a particular country or period, such as Germany, Russia or the USA at key moments in their history
- The study of either a famous individual from the past in whom students are particularly interested or an historical site.

ASSESSMENT

The assessment of Entry Level History is very simple and straightforward – students must complete three tasks that make up 100% of the assessment.

These tasks are set by your centre so you can target your students' interests. They can be structured or can allow more extended writing to suit their abilities. We've produced a task booklet of exemplar materials to use or adapt for the first two tasks if you prefer.

THE OUALIFICATION

You can select from a wide range of content options to meet your centre's expertise in our GCSE (9–1) in History A. Our modern options will give your students a chance to study the narrative of 20th century international relations and the forces that shaped those relations with a view to assessing how far they're still influencing events today. They'll also study one non-British country in depth, focusing on the key issue of the relationship between the people and the state.

Our thematic options give students the chance to study a broad sweep of history, looking at themes that are just as relevant today as they were in the medieval and early modern periods, albeit sometimes in very different ways.

Our British depth studies, linked to our thematic options, enable students to learn about a fundamental issue in British history – one whose effects are still felt today.

Our site study is the final element. The site, which we specify in the specification, allows students to study the historical environment. Our exciting resources for this element have been produced in conjunction with English Heritage and the Black and Asian Studies Association (BASA).

ASSESSMENT

OCR's GCSE (9–1) in History A consists of three components that are externally assessed. Each component is examined by one written paper.

- Component group 1 –
 Period study and non-British depth study –
 50% of the total GCSE
- Component group 2 –
 Thematic study 25% of the total GCSE
- Component group 3 –
 British depth study with a study of the historic environment –
 25% of the total GCSE.

THE OUALIFICATION

Our GCSE (9-1) History B (SHP) is an exciting history course designed to fire students' enthusiasm for studying history. It's been constructed in partnership with the Schools History Project and reflects SHP's principles for ensuring worthwhile and inspiring school history.

History B (SHP) encourages students to become curious, to develop their own opinions based on a respect for evidence, and to build a deeper understanding of the present by engaging with and questioning the past. The specification is based on content that helps students to address fundamental issues in human history.

It brings together people, events and issues that we think students will find fascinating and that aim to stimulate a desire to explore the similarities and differences between people's lives in the past and their own lives now.

ASSESSMENT

OCR GCSE (9-1) in History B (SHP) has five elements organised into three component groups for the purpose of assessment. Students take three components, one from each component group:

- Component Group 1 British History
 - · Thematic study
- · British depth study
- · Component Group 2 History Around Us
 - · The site study
- Component Group 3 World History
 - · Period study
 - · World depth study

The equal weighting given to the five studies, each representing 20% of the GCSE (9–1), provides a clear and consistent structure that's helpful for course planning. A balance across periods is maintained by providing an equal number of options for medieval, early modern and modern history.

- Unit group 1 of both the AS and A Level courses is a British period study and enquiry.
- Unit group 2 of both the AS and A Level courses is a non-British study, similar to Unit group 1 but excluding the enquiry.
- Unit group 3 (A Level only) is a historical themes and interpretations unit.
- Unit group 4 (A Level only) is the internally assessed element of the course and provides students with the opportunity to explore a topic of personal interest through coursework.

ASSESSMENT

- Unit groups 1 to 3 are assessed entirely through written examinations that are externally marked.
- Unit group 4 is assessed internally, then moderated externally.






