

# **Replacement Certificate Fees 2025/26**

### **General qualifications and Cambridge Nationals**

Centres have one month to report missing certificates in order to obtain a free replacement. After this date, there will be a charge. Replacement certificates will only be issued for six months from the date of issue (except where a grade has changed as a consequence of a review of results, in which case replacements will be issued free of charge up to a year from the date of issue). After this date, centres must apply instead for certifying statements of results.

## Cambridge Technicals, Vocational qualifications

### **Replacement certificates**

Replacement certificates for vocational qualifications can be claimed free of charge within the first three months from the date of certification.
